### President's Report

We are almost two months into the New Year and things are heating up at SRV. Our weather is returning to the warmer winter temperatures we are used to in Florida and are very thankful that we have been spared the extreme cold weather the most of the rest of the country has been experiencing. Our social programs are off to a great start this year and I want to thank Joe Morganstern and his Programs and Services committee for the return of social events that are being held safely at our Clubhouse pool area. Joe and Bob Martucci (Clubhouse Committee) have worked together to add a Ping-Pong table to SRV and move our pool table to the main room where it can be played without the constraints of the small room it has been in for years. Also a big thanks goes out to Sue Knapp and the Grounds Committee for setting up a very informative meeting between the Board of Directors and our Landscape Company, Bloomings Landscape and Turf Management, for a review of our Landscape Enhancement Program and all the thought and effort that went into that program to pick the right plants to cut the labor hours Bloomings would have spent with other varieties of plants. We were pleased to hear Sue and Bloomings have worked out a test of a new water meter, new technology that was not available when this program began, that can monitor weather conditions, humidity, temperatures, daylight hours etc., and may cut our irrigation water use by 30%. We are all very conscious of our water usage and are continually looking for ways to reduce that expense. If these new Smart Meters preform as they say they will it will be something we look at in the future to add to our irrigation system. Bloomings also made some suggestions that we can look at in the future that have higher startup costs, but would help reduce future water and sewer costs. Those startup costs need to be reviewed to see how much a return on investment we would expect. Thank you to Sue Knapp for continuing working to find solutions to these issues. Most of our other committees are busy working on their projects and areas of responsibilities and we should expect to see more exciting ideas in the future. Don't forget if you want to help out on any of our committees or just attend a committee meeting to listen in on what is in the works, contact our committee chairs which are listed on page two of our *News & Views* newsletter each month. New ideas and volunteers help SRV remain the great community it is and has always been.

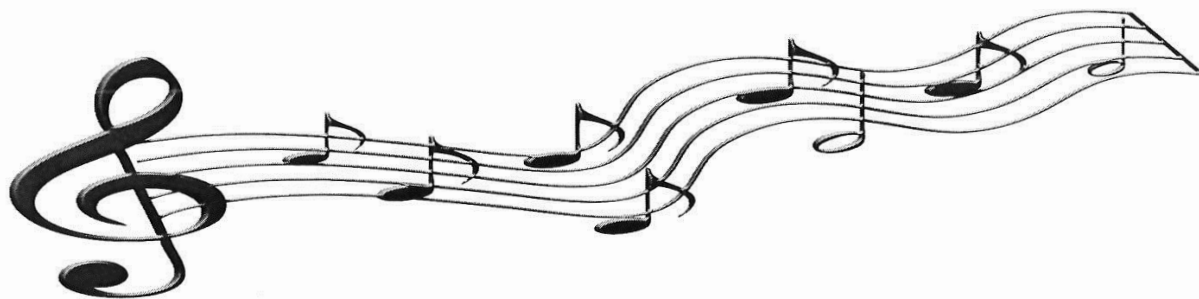

# Grounds Report



February 25, 2021

**Irrigation** has been an issue for all of us. As noted in Larry's Presidents report a few members of the Board attended an overview with Blooming's Landscape and Turf to receive an understanding of the purpose of the Landscape Enhancement Project. Three previous boards viewed the presentation and approved the project as it began in 2014. With that understanding we had a discussion regarding the irrigation and determined it was possible to try another type of rain sensor. At the onset of this project, it was decided to use a "solar rain sensor" rather than any electric process. These solar rain sensors work as a small sponge fills with water and shuts off the irrigation when raining. However, many of those sponges need replacing as they dry out and are not affective. These will be replaced throughout the community within the next few weeks and replaced on an annual basis.

Good news is that we are going to have an opportunity to try another system which is a Smart Meter/Weather Station. Before we move forward with accepting this change for all rain sensors, we are going to install one Smart Meter/Weather Station and another Water Meter with same irrigation units for comparisons on usage. The members of the Board who attended this meeting were in complete agreement to move forward with this test. It is a possible 30% savings on our irrigation costs.

Blooming's will provide the Smart Meter/Weather Station and Meter at both units without a fee to SRV. These units will be installed in March and tested through September. The Water Task Force committee and Grounds team will evaluate the results and present facts to the Board members. After we have received the calculations of the measurements, we will request a Grant to offset the expense of the monitors if we decide to accept this solution.

The biggest attraction about this sensor is the "quick shut off" feature for rain. The manufacturer claims that within 2 minutes it will shut down the system. There is no wait for accumulated rain fall. The sensor can be programmed to remain off after the sensor dried out for several days. For example, if it rained heavy, but the rain sensor part dried out in 2 days we could program it to wait an additional number of days before watering again. Hunter industries did not offer that 5 years ago but now they do, and we have all Hunter irrigation units so it will be compatible. This quick shut off feature for the rain sensor is what makes this good for our community.

Everyone is concerned about the costs of water and sewage and irrigation is a contributor to those costs. This is a step to improve our situation with a "test" and measurements for a full evaluation.

Leaves Leaves leaves! All over the area even after they were swept away! This is the time of year in Florida. Just a reminder that the landscaping in Florida is different than "up north" in many ways. This is our "Winter or Fall". Trees are dropping their leaves and the plants are resting. Many areas have been evaluated and sod is being replaced on an as needed basis.

Notify the office through a work order if you have questions or requests regarding your landscape. There is a preferred list of plantings in the office for you to pick up. Plantings can be installed by residents in the area along the sidewalk by the driveway (not in front of the villa) to the front door and the side and back of the villa after approval from the Grounds committee.

Plantings in front may not be changed, added, or removed. Submit a work order for replacement of dead plants.

Reminders: Red Ribbons can be placed on plants you do not want to have trimmed.

Pick up of trimmings: DO NOT put your clippings out until after 6 PM on Sunday night. Not earlier. Blooming's will pick up on Mondays after 3PM. This is our way of keeping the community tidy rather than having these debris out all weekends. Thank you.

# Building Committee Report



The Building Committee has been very busy assessing projects and prioritizing tasks at hand. Our goal has been to identify areas where we can create revenue, reduce expenses and enhance amenities at SRV. We have identified spaces within our boundaries that can either be repurposed or expanded to achieve our goals. First off, we have identified an area at the northwest corner of our property on the water that provides access for a perfect kayak launch or an opportunity for anglers at SRV to walk into the water and enjoy hours of fishing. We would also like to build a kayak rack in this area for easy access to the water. For those of you that have motor homes, trailers or pull your boats out of the water during the summer, we would like to convert the fenced in storage area into a rental lot. The rental lot will provide revenue for SRV and provide another amenity for our residents. We are working on wording to put patio doors up for a vote again. The wording will be more specific regarding access to keyholes or the rear of units that don't have a key-hole. We have prioritized the rear of the Creekside villas as an area we need to focus on for safety, erosion

and aesthetics. The results of our survey come from three years of data compiled by members of the building committee. Discussions on a plan to remedy our issues will come from the Building, Grounds and Safety Committees. There have been numerous requests for modifications to villas. We need your help to expedite the process. When you fill out a modification form, when required, please be sure to add your contractor's business license, insurance information that includes valid liability and workman's comp dates, also include the permit number. Your contractor may get their permit just prior to starting your job. Once your job is completed and the county has come to your villa for a final inspection, please be sure to check the county website to be sure your permit is closed. At that point inform the building committee your remodel has been completed and the permit is closed. During the month of March I hope to be passing on more news for you.

# Larry's Bio

## HE FLIES THROUGH THE AIR.....

*with the greatest of ease, the daring young man on the flying trapeze.....*

Ah...the circus, P.T. Barnum said "from 6 to 60 found unending entertainment". Through a child's eyes the men and ladies flying through the air were always magical. Well, we are fortunate to have one of those childhood heroes living on our street and around the corner. Please meet Larry Gill our illustrious President.

Having been born in Pennsylvania, the Gill family moved to Sarasota in 1964. As a young boy, Larry was introduced to gymnastics so his career began at 13 years of age. After school he joined the Amateur Circus Activities held at the Sailor Circus in Sarasota. Here he learned to put up Big Top tents, all riggings (acrobatic and aerial), building nets, trapezes and splicing ropes; these were among his early skills. Three days after graduating Sarasota High he returned to Pennsylvania where he performed on the Flying Trapeze. His career was interrupted when he enlisted with a friend in the Marine Corp, where they both were stationed at Camp Lejeune in North Carolina and Guantanamo Bay, Cuba. After only two years he was discharged as an E5 Sargent.

Being restless, Larry and his friend again returned to the Circus flying internationally. In 1974, he and his wife started their own Flying Trapeze act. He was in charge of booking, setting up and breaking down, making costumes and clever enough to be in charge of his own rigging. They spent 12 years performing with circuses, appearing on TV, Dazzling spectators at sporting events, fairs, amusement parks and the like. A long list of scary aerial tricks included "The Passing Leap" and the legendary "Triple Somersault".

Larry's circus career afforded him and his family a working tour of the United States, Mexico, Jamaica and Japan along with two tours throughout Canada. Their travels, along with home schooling, gave his children an educational advantage; because when Larry decided to retire from the Circus and enter his two daughters in Public School they were a grade ahead of their peers. He did this as he felt they were missing the social activities that school offered. Aside from all family obligations, Larry was responsible for all on-the-job failures and successes causing him to learn patience and discipline to become the wonderful leader he is today.

Upon Larry and his family's return to Sarasota, he volunteered at the Sailor Circus as a coach on the flying trapeze acts and taught the complicated rigging skills. During this time he also created and ran a small Three Ring Rigging Supply company selling to circus acts and entertainment venues.

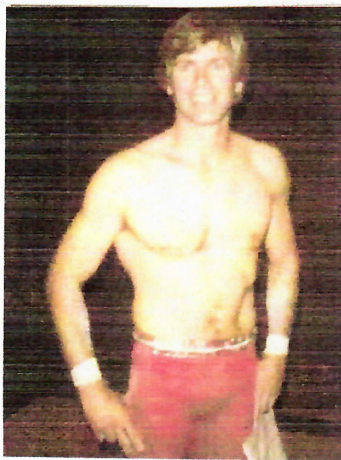
A few years later, Larry received a call from Cirque du Soleil "O". He looked forward to the opportunity of returning to entertainment and after an interview was hired and eventually became Head of Rigging. Larry retired from this special job in 2016. With all his exceptional skills and responsibilities he managed to become a certified trainer for Fall Protection, Aerial Work Platforms...and...a Master Scuba Diver earning certification in Rescue Scuba Diving.

When Larry decided to hang up all Circus gear and begin a different career, he joined the local Anheuser-Busch Distributor as area Sales Manager and for 16 years serviced many local events.

Larry and his cute fun-loving wife Linda purchased their Villa in 2013 and have resided full time since Larry's retirement. In 2017 he was elected, chaired the Safety & Security Committee for two years. He was assigned Vice President for his second term. In December 2020, Su Harley resigned and Larry was elected Board President as he remains today.

If you're not familiar with lovely Linda and Larry, you'll find them at Shuffleboard courts on Wednesday morning's. And...you thought you had an exciting career...meet the man who flew through the air on the *Flying Trapeze!!*

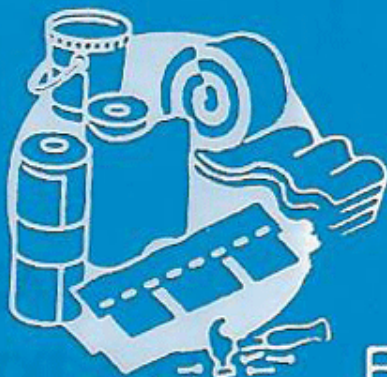
