#### President's Report:

#### Update on Sarasota recycling container replacements.

Larry Alexander, Solid Waste Division Manager has told us that the County is buying smaller containers for SRV. These containers will be 35 gallon carts on wheels to replace the two (red & blue) containers we currently have.

One container will be delivered to each Villa sometime in November. New service will start County wide with the new container on January 6, 2020.

The County at first had no plans to retrieve the red and blue containers that we are currently using. However, I have negotiated with Larry Alexander to pick up the red and blue containers at a date to be determined in January 2020 from those residents that have no further use for them.

We plan to have one location for residents to drop off the old containers for a one time pick up by the County. Information for this one time pick up will be communicated to all residents once we hear from the County in January.



# Grounds Report



October, 2019

As the end of 2019 draws to a close, SRV will be completing a few remaining tasks regarding landscaping. First, the annual pruning of over 500 palm trees is scheduled to begin the week of October 14. The trees will have all of the brown fronds and seed pods removed, with the tree left with a “9-3” canopy shape. The cost of this annual task is \$8,925.00

Secondly, the pruning of the four large areas of mangroves will be completed by the end of October at a cost of \$1,700. A specialty tree service that holds a special state and county permit authorizing the trimming of the protected plants, will complete the work.

Thirdly, application of mulch will be complete sometime in mid-November. The details of this annual task will be provided in the November Newsletter.

Finally, I wish to thank all of the volunteers of the Grounds Landscape Team for their hard work these past few months. These dedicated individuals work in service to SRV owners and we owe deep gratitude to these wonderful people.

# Building Committee Report

---



October 18, 2019

A Building Committee Meeting was held October 8, 2019. Items on the agenda are listed below.

**Road Sealing:** Sealing by Asphalt Repair Service is progressing and should be finished by the end of October. The Committee thanks everyone for their patience and cooperation during this INCONVENIENCE,. Shawn has done a great job in setting up cones to direct traffic and getting out the ONE CALL notices

**Pickelball – Bocce Ball Courts:** It is suggested that SRV residents investigate using the many existing Pickelball Courts that are available in the County and City Parks as research continues. It is suggested that an interest survey for these activities be prepared and administered by SRV Programs and Services Committees.

**Shuffleboard Court Covers:** We reviewed some estimates which were very costly. We are looking for lower cost covers or assessing the need for any cover at all, since the use of the courts during the year is low except for the Jan-Feb. competition.

**Villa Painting:** Villa painting in section one is nearing completion. The BOD voted on a 5 year contract at the Sept. BOD meeting. The 5 year contract was approved. SRV will now be on the painting contractors' yearly schedule for the following years. This gives SRV a more convenient time of the year for SRV painting to be scheduled.

**Boat Dock Warranty Repair:** Justin Gonzalez LCAM, Argus Property Management, has contacted two Engineering Companies to offer opinions on the Boat Dock Repair as recommended by Att. Sanjay Kurian in the 9/06/19 phone call meeting. Dates have not been scheduled for their inspections at this time. Previously, materials and documents were gathered and assembled. Justin Gonzalez LCAM, Argus Property Management, took that information and prepared a letter which was sent to Att. Jennifer Horan, Becker & Poliakoff, for evaluation and recommendation as to how to proceed. Att. Jennifer referred SRV to Att. Sanjay Kurian a Board Certified Construction Law Att. The resulting phone meeting 9/06/19 with Att. Sanjay Kurian and Att. Jennifer Horan was attended by Justin Gonzalez, Jerry McDermott, Steve Zimmerman, Don Puls and Shawn Gubody. Att. Kurian recommended SRV have an out of the area Engineer give SRV an opinion of how the job should have been done correctly before SRV proceeds.

**Swimming Pool Pumps:** Replacement and repairs of the pumps and valves has been completed and the pool was drained and checked and refilled with fresh water.. A complete replacement of the Pump House structure is being investigated.

**Villa Alterations and Repair:** In order for the SRV Board of Directors to approve any alterations or repairs to your villa, a **“Request to Modify Condominium Property”** form must be completed and submitted to the office with a copy of the **Sarasota County Building Permit**, and copies of the **Contractor License and proof of Liability Insurance**.

These Documents are **REQUIRED** by Sarasota County and the SRV Rules and Regulations before the work can be **APPROVED** by the SRV Board and **BEFORE the WORK can begin. If the work is started without approval the WORK will be stopped and Sarasota County will be notified which could cause a FINE by the county and/or reversal of the work.** The “Request to Modify Condominium Property” form and Sarasota County Permit information sheet are available from the SRV office

# Landscape Enhancement “5 Year” Project Plan

October 2019

Yesterday a resident stated.....”5 years ago” **I never believed this would be completed. Now it is a beautiful improvement for the property.** “

It was just **5 years ago** the Grounds committee members, Dale Leinberger, Sue Zimmerman, and Dewey Nugent and I began an endeavor to improve the landscape in SRV. Beginning in 2014 and for the first time in history of SRV we invited vendors to attend a meeting to be asked to bid on our landscape maintenance.

The final question was asked of all vendors, “Please provide with your expertise a way we can improve our landscape for 336 villas”. The *only* vendor who produced an “idea” of value was Blooming’s Landscape and Turf, Inc.! At the time this”5 Year” Project Plan was presented to the the Board of Directors and Argus Property Vice President and all agreed 100 per cent to move forward with the concept. Obviously change is a “challenge” and the Project Plan was met with resistance. Meetings were held to inform the residents of the purpose and Phases and we moved forward answering issues as questioned.

There have been 336 Jatropha trees installed in front of villas, additional palms, plants, St. Augustine sod, mulch and irrigation. The “As Built” irrigation diagrams have been submitted to the office. These improvements have been challenging. Some plants didn’t thrive and have been replaced.

This project was a challenge SRV and Bloomings continued to work as a team to make this a success. Bloomings attended planning / project meetings. For this Final Phase there were obstacles that could have postponed the project deadline however Bloomings dedicated additional staff to finish the project on time! Every deadline was met “on time”,

There were others who participated on the committee over the years and ***I thank them*** for their advice and cooperation with this project. Dale Leinberger, Dewey Nugent, Sue Zimmerman, Don and Margaret Quitter, Bill and Kathryn Hallisey, Roberta Chandley, Celia Cooper, Kathy and Pat Garthwaite, Bob Robbins, Jean Burns, Shawn and Nan. This project was a huge endeavor and all of the committee members who participated deserve a real big “Thank YOU”. They never gave up and for that SRV should be appreciative.

A resident in the last phase section stated “ Thank you all- Where can you live where the association paints your villa, paves the street and to top it off they provide new sod, irrigation installation, plants and a beautiful tree”.

These Guest Parking permits are reusable and can be kept at your villa to use when needed. 


